For a firm's top executive to win, he or she needs to have consistently demonstrated clarity of vision, judgment and motivational skills that transform and empower their organization. The winner will be a leader who is highly respected by both peers and competitors, admired and followed by employees, trusted by investors and welcomed by the community.

This award recognizes courage, perseverance, dedication, ethics and the ability to advance their company in the face of adversity, sustain their sector amid universal headwinds and undeniably support the employees who propel their organization into the future.

Entries should focus on a leader's strategy and objectives, clear communication and implementation and ultimate outcome substantiated by demonstrable progress toward his/her vision.

Judges will consider a leader's entire track record, with particular attention focused on that individual's accomplishments since January 2019.
