*Winning entries might focus on overcoming challenges to complete the deal, innovative financial engineering, and motivating agreement across multiple stakeholders.*

*Note: Energy investment portfolio businesses should not submit their whole portfolio for consideration. More than one nomination can be submitted for Deal of the Year as long as they are completely separate deals.*

*In the interests of judging the success of an investment, judges will consider any investment made since January 2019 through the close of nominations in September 2020.*
